EXPERIENCE HIGHLIGHTS

Insurance Coverage

David defends clients against property damage disputes involving matters such as fire, theft, and coverage issues arising out of catastrophic events. His practice also includes representing insurers and their insureds in complex liability matters, including construction defect actions arising out of large multi-family construction projects, catastrophic personal injury and wrongful death claims, defective product actions, and professional negligence claims.

- Secured summary judgment victory in a wrongful death action, prevailing on a no coverage determination based on the application of the Assault & Battery exclusion in the policy. The case involved novel arguments related to public policy under a South Carolina statute requiring liquor liability coverage as well as arguments related to illusory coverage.
- Obtained favorable judgment on the pleadings for a client involving an \$18 million underlying judgment. Despite the plaintiff's argument that the underlying complaint sufficiently alleged liquor liability in order to trigger a coverage obligation under the Liquor Liability policy at issue, the court found no coverage for the claim under our client's policy.
