EXPERIENCE HIGHLIGHTS

Product Liability

David has acted as national counsel for a number of product manufacturers throughout the United States and Canada. Among his successes in product liability are the following:

- Successfully defending a major national retailer on appeal before the Eighth Circuit in a significant negligence and product defect decision in which the court ruled the plaintiff brought insufficient evidence to exclude other forces that may have affected the product in the 20 years before the injury occurred
- Defeating product liability claims through Daubert exclusions of expert witness testimony, including, for example, convincing the Seventh Circuit to uphold a trial court's ruling on the inadmissibility of an engineer's expert methodology for analysis of a vehicle accident
- Successfully defending one of the premier manufacturers of home appliances in fire cases, including before the Seventh Circuit in a case involving spoliation of evidence issues over an expert witness's handling of a product in a way that denied the defendant the means to demonstrate an alternative cause of the fire
- Obtaining summary judgment in favor of the manufacturer of a deep fryer in a significant personal injury case involving allegations of failure to warn and defective design

Management and Professional Liability

David handles a wide range of professional liability cases, including the defense of architects, engineers, and surveyors in claims and lawsuits involving personal injury and errors and omissions. His successes in this area include:

• Defending the world's largest retailer in a workplace-injury case under the Illinois Structural Work Act, which was repealed by the legislature after the plaintiff filed suit
