Jonathan S. He has worked with accounting firms preparing for grand jury appearances.

Jonathan has also represented lawyers and law firms in professional negligence matters, including one matter involving an alleged staged motor vehicle accident ring, for which a federal grand jury had been convened. He is also hired by law firm managing partners to handle their firm's business and employment-related litigation.
