Joseph M. Hanna is a highly experienced litigator and legal adviser recognized for his national practice in retail and hospitality and sports and entertainment law. Acknowledged nationally and regionally as an advocate and trailblazer, Joe earned the President's Lifetime Achievement Award, the highest civil volunteerism award presented by the President of the United States (2022). He was also the youngest honoree ever to be named Lawyer of the Year in the Bar Association of Erie County's 130-year history (2015).

He has served in multiple leadership roles in the Leadership Council on Legal Diversity (LCLD) and was recognized with the organization's highest honor, the Rick Palmore Alumni Award.
