Thaddeus J. In addition, he has extensive experience handling matters related to New Jersey's Economic Loss Doctrine, including applying it to dismiss multimillion-dollar claims against clients.

Ted is certified as a civil trial attorney by the New Jersey Supreme Court, which recognizes sufficient levels of experience, education, knowledge, and skill in civil trial practice. The certification—bestowed on only three percent of attorneys practicing in the state—draws on extensive evaluations from adversaries, fellow civil trial lawyers, and judges. Automobile Liability and Personal Injury

- Obtained dismissal at trial in a case involving claims for traumatic brain and spinal injuries after the plaintiff's medical expert admitted on cross-examination that he could not opine within a reasonable degree of medical probability that the injuries were caused by the accident
- Represented client in a jury trial that found the defendant was not negligent in a motor vehicle accident in which an eyewitness to the accident blamed the defendant and the plaintiff underwent a lumbar fusion surgery
- Obtained a defense verdict in a premises liability trial in which the plaintiff alleged traumatic brain, spinal, and dental injuries
- Obtained a defense verdict after establishing that the plaintiff's treating neurosurgeon changed his opinion claiming the plaintiff needed surgery to enhance damages at trial
- Successfully barred a plaintiff's economic expert in a wrongful death action resulting in favorable settlement
- Appellate Division affirmed dismissal of a plaintiff's personal injury claim for bilateral wrist fractures due to the plaintiff failing to produce evidence of the defendant's negligence for motor vehicle intersection collision
- Appellate Division reversed trial court's decision to allow a plaintiff's claim for underinsured motorists benefits holding the claim was time-barred by the statute of limitations
- Appellate Division affirmed a trial verdict finding that the plaintiff did not establish the defendant was negligent by a preponderance of the evidence
