- Representing a general contractor after an employee suffered a leg amputation – OSHA withdrew the entire citation
- Successfully filing a Petition for Discretionary Review with the Occupational Safety & Health Review Commission in a fatality case involving a painter and electrical transmission tower

In addition to his OSHA practice, Michael defends owners and contractors through trial in high-exposure construction actions alleging violations of the New York Labor Law — including the "Scaffold Law."
